**ORAL ORDER**

1. The petitioner in W.P.No. 5691/2021 is before this

Court seeking for the following reliefs:

- a. Issue a writ of certiorari or any other writ, order or direction, quashing the show cause notice dated 25.02.2020 bearing T-4/SRO/SDE/BGZO/01/2020 issued by R2 (Annexure-A).*
- b. Consequently, issue a writ of certiorari or any other writ, order or direction, quashing the complaint dated 25.10.2019 bearing No. T-3/BGZO/96/2018 filed by the R3 before the R2 (Annexure-B).*
- c. Grant such other reliefs as this Hon'ble Court deems fit in the above circumstances of the case, in the interests of justice and equity.*

2. The petitioner in W.P.No. 4711/2021 is before this

Court seeking for the following reliefs:

- a. Issue a writ of certiorari or any other writ, order or direction, quashing the show cause notice dated 25.02.2020 bearing T-4/SRO/SDE/BGZO/01/2020 issued by R2 (Annexure-A).*
- b. Consequently, issue a writ of certiorari or any other writ, order or direction, quashing the complaint dated 25.10.2019 bearing No. T-3/BGZO/96/2018 filed by the R3 before the R2 (Annexure-B).*
- c. Grant such other reliefs as this Hon'ble Court deems fit in the above circumstances of the case, in the interests of justice and equity.*

3. The submission of learned counsel for the petitioners is that the lis in the above matters is covered by the decision dated 6.12.0224 of a Coordinate Bench of this Court in the case of **Mrs.Kshithija Urs -v- Union of India and others** [WP No.1418/2021]. Since the proceedings in the present matter had also been initiated after the omission of Section 6(3)(b) of the Foreign Exchange Management Act, 1999 [**'FEMA'** for short], there is no particular dispute about the said position.
4. In that view of the matter, applying the dicta laid down by the Coordinate Bench of this court in its order dated 6.12.2025 passed in W.P. No.1418/2021, the above petition is require to be allowed. As such, I pass the following:

ORDER

- i. The Writ petitions are allowed.
